

JOINT MOTION FOR ENTRY OF STIPULATIONS AND  
APPROVAL OF PROPOSED SETTLEMENT

ON THE JOINT MOTION OF:

1. the Louisiana Department of Public Safety and Corrections, Office of State Police, Video Gaming Division (hereinafter "Division"), and
2. Dixie Inn Deli, Video Gaming License #6007211899 (hereinafter "licensee"), who respectfully represent the following:


WHEREAS:

1. On January 31, 2001, the Division conducted an on-site inspection of the Licensee. During the course of the inspection, the Division issued the Licensee Violation and Inspection #012180 wherein it was alleged that the Licensee violated LAC 42:XI.2407(A)(8) for failing to have a designated representative on the premises.
2. On February 19, 2001, the Division issued the Licensee a Notice of Violation in connection with Violation and Inspection Report #00012180.
3. Present on the licensed premises during the January 31, 2001 inspection was Ms. Kala Gotshall, an individual who has previously submitted to suitability but was not on the Licensee's designated representative list.

The Division and licensee have had the occasion to review all of the facts and circumstances attendant to the violations and agree and stipulate as follows:

1. The Division agrees to dismiss the violation of LAC 42:XI.2407(A)(8) alleging that Licensee failed to have a designated representative on the licensed premises on January 31, 2001



2. The Licensee acknowledges that it violated LAC 42:XI.2407(B)(4) in that it failed to list Kala Gotshall on the list of designated representative for Dixie Inn Deli.
3. The licensee shall pay the sum of one hundred dollars and 00/100 (\$100 00/100) for its first violation of LAC 42:XI.2407(B)(4);
4. The Licensee shall provide a current list of designated representatives;
4. The Division hereby agrees to accept the licensee's payment of the above stated penalty in full and final settlement of Violation/Inspection Report No. 012180;
5. The Division reserves the right to take into consideration these violations in connection with any future violation;
6. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;
7. This settlement constitutes the entire agreement between the Division and Dixie Inn Deli pertaining to the subject matter contained, herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties;
8. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board; it is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its determination as to whether the matter should be heard by the Hearing Officer; if approved, however, payment of the above penalties must be submitted to the Division within fifteen (15) days of approval of this settlement by the Board;
9. The failure of the licensee to submit the above penalties within fifteen (15) days of approval of this settlement by the Board shall result in the suspension of its license; and
10. The Division and the licensee waive their rights to appeal this settlement if the Order is signed by the Hearing Officer and accepted by the Board.

ORDER

Considering the foregoing Joint Motion For Entry of Stipulations and Approval of Proposed Settlement, IT IS HEREBY ORDERED that such proposed settlement be approved, to wit:

1. The Division dismisses the allegations that Dixie Inn Deli violated LAC LAC 42:XI.2407(A)(8);
2. Dixie Inn Deli admits that it violated **LAC 42:XI.2407(B)(4)** by failing to list Kala Gotshall on its current list of designated representatives and agrees to pay the sum of one hundred dollars and 00/100 (\$100 00/100) for its first violation of **LAC 42:XI.2407(B)(4)** ;
3. Dixie Inn Deli shall submit to the Division a current list of designated representatives within fifteen days of approval of this settlement;
4. Payment of the above penalty shall be submitted to the Division within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board;
5. Failure by Dixie Inn Deli to submit the above penalty and the current list of designated representative within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board shall result in the suspension of its license.
